

**GRAND RIDGE PLAZA
THE 25K SILVER STEPS WALK CHALLENGE
Official Rules**

NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS, RULES AND REGULATIONS APPLY. ODDS OF WINNING DEPEND ON THE NUMBER OF ELIGIBLE ENTRIES TIMELY RECEIVED. VOID WHERE PROHIBITED.

- 1. SWEEPSTAKES PERIOD:** The 25K Silver Steps Walk Challenge Sweepstakes (the “Sweepstakes”) will begin at 12:00 a.m. P.T. on Monday, May 1, 2023 and end at 11:59 p.m. P.T. on Wednesday, May 31, 2023 (“Sweepstakes Period”).
- 2. SPONSOR:** The Sweepstakes is sponsored by Regency Centers, L.P. (“Regency” or “Sponsor”), One Independent Drive, Suite 114, Jacksonville, Florida 32202.
- 3. ELIGIBILITY:** To enter or win, Entrant must be a legal resident of the state of Washington and who is 18 years of age or older as of May 1, 2023 (the “Entrant”). By submitting an entry, you accept and agree to abide by these Official Rules. Sponsor is not responsible for late, illegible, corrupted, or misdirected entries. Entries generated by script, macro, robotic, programmed, or any other automated means are prohibited and will be disqualified.

- 5. PRIZE & APPROXIMATE RETAIL VALUES:** There will be ten (10) prize winners. Each winner will receive a one (1) \$250.00 Grand Ridge Plaza electronic gift card.

The approximate retail value of all prizes is \$2,500.00.

The prize winner is solely responsible for all applicable federal, state and local taxes and/or any other fees/costs associated with the prize or receipt of the prize. Any and all guarantees and warranties for prizes are subject to the manufacturer's and/or service providers terms and conditions, and winner agrees to look solely to such manufacturers and/or service providers for any warranty or guarantee claim. Selection of the prize winning entries shall be made on a random basis and not based on the merits of the submission; provided that Sponsor in its sole discretion may disqualify any entry that does not conform to the requirements outlined above in the "How to Enter" section. Drawing will be conducted in accordance with the Official Rules by Sponsor, whose decisions on all matters related to the Sweepstakes are binding and final. Potential winner will be notified via phone or email and will be instructed to provide contact information within seven (7) days or the prize will be forfeited and an alternate potential winner will be chosen. The Entrant will need to scan the QR Code on the trivia challenge poster and answer the trivia question correctly for a chance to receive a reward. Winners of the reward will be selected in random drawings throughout the Sweepstakes Period. If an Entrant is selected to receive an additional reward, the Entrant is required to follow the provided instructions to claim his or her reward. Each reward is valued at \$100.00 or less.

8. PUBLICITY RELEASE: By submitting an entry, by entering these Sweepstakes, or by accepting the above prize, the winner consents that Regency may use of his/her name, likeness, photograph, statements, biographical information, voice and address (city and state), and otherwise, in all forms of media, in perpetuity, without notice or further compensation, except where prohibited by law. 9. ODDS OF WINNING: Odds of winning the prize will depend on the total number of timely eligible entries received by the required entry method.
